<p><u>DETERMINATION OF HORSEPOWER CONNECTED</u></p> <p>The horsepower of connected load for billing purposes shall be the manufacturer's nameplate rating of the motor. If the Seller so elects, the horsepower shall be determined by actual measurements of power input during a period of maximum normal use less an allowance to ten percent of input for motor losses.</p> <p><u>POWER FACTOR ADJUSTMENT</u></p> <p>The member and consumer agrees to maintain unity power factor as nearly as practicable.</p> <p><u>TERMS OF PAYMENT</u></p> <p>Meters will be read and usage billed as per Rules & Regulations.
